



In accordance with the Bylaws and Policies of the Kelowna Chamber of Commerce, nominations for election to the Board of Directors are to be open to members in good standing one month prior to voting for elected positions on the Board of Directors. Nominees are encouraged to be aware of the following:

- A. The completed nomination application form along with your picture must be received by the Chamber as soon as possible but no later than 4:30 pm on **Thursday February 1, 2024** to be considered.
- B. Nomination forms will be reviewed by the Governance and Board Development Committee (The Committee) and interviews may be requested if time allows.
- C. The Committee will complete their review and make recommendations to the Board in accordance with Kelowna Chamber policy. Those candidates being recommended for the Board will be identified as such on the electronic ballot that will be sent to all members.
- D. All eligible candidate profiles will be posted on the Chamber website for the information of members.
- E. Online voting will take place between Monday February 5, 2024 and Friday February 16, 2024.
- F. The results of the online voting will be tabulated on **Friday February 16**, **2024** and the results of the voting will be put before members at the Annual General Meeting on **Thursday March 28**, **2024**.
- G. Protecting your privacy and the confidentiality of your information over the Internet, on the telephone, or through our offices has always been fundamental to the way we do business at the Kelowna Chamber of Commerce. We respect the privacy of individuals who engage with the organization and only collect personal information related to the purpose identified. A Director of the Kelowna Chamber must be committed to leadership and is expected to perform specific duties within the business community. To provide you with insight regarding the responsibilities and commitments of an individual member of the Board of Directors, we are providing you with information on the responsibilities of Directors and background on the election process.

#### WHAT IS EXPECTED OF DIRECTORS?

The Kelowna Chamber has established criteria to guide the Board in determining which candidates should be recommended for election. This policy in part states that the Committee will recommend a slate of eligible candidates for consideration and that recommended candidates and incumbents will be identified on the ballot.

The bylaws mandate that any elected Director shall be a member in good standing, free of any conflict of interest and be willing and able to attend board meetings on a regular basis. In addition, it is highly desirable that candidates be familiar with the Kelowna Chamber's goals and objectives. Copies of the Chamber's bylaws, Board Policy Manual, and Board Strategic Plan are available upon request.



Current involvement in a Chamber committee is an excellent way for a candidate to gain experience and demonstrate commitment. In addition, the Board recognizes that to be effective it should be diverse, inclusive, and represent as broad a range of industry sectors as possible. This is important for the Chamber Board to be effective, forward thinking, and provide worthwhile input to municipal, provincial, and federal regulators on a variety of issues.

- > Not be a current employee or contractor with any Chamber or Board of Trade.
- Not be in a conflict-of-interest position with respect to the Chamber (i.e. a representative of a supplier or business partner of the Chamber).

#### Candidates should

- > Have governance (Board/Committee) or executive level experience in a business or organization of similar or greater size/complexity to the Kelowna Chamber.
- > Have experience in a leadership position working in a team environment.
- > Understand the vision, mission, and values of the Kelowna Chamber.
- > Have the support of their employer to hold the position of Director.

#### Furthermore, Directors are expected to make best effort to:

- > Attend all Board meetings.
- > Attend the Board's Annual Retreat, estimated half day in length.
- > Participate in assigned Board Committee meetings.
- > Assist with efforts to help the Chamber grow. For example, identify and introduce potential new members, or invite non-members to Chamber events.
- > Promote the value proposition, work, programs, and events of the Chamber.
